Instructions for completing the form:

3. Number of closed cases (C): Refers to the number of appeal cases in which the appellant withdrew the appeal (D) on their own or the appeal review panel made an appeal decision in accordance with the law (E) after the appellant filed an appeal.
4. Number of cases withdrawn by the appellant (D): Refers to the number of appeal cases in which the appellant voluntarily withdrew the appeal before the delivery of the decision.
5. Number of accepted appeals (E): Refers to the total number of appeal cases accepted by the agency, including cases with valid grounds (F), cases without valid grounds (G), cases with some valid and some invalid grounds (H), cases with some valid grounds but not accepted (I),
6. Number of appeals not accepted (L): Refers to the number of appeal cases in which the agency ultimately did not accept the appeal based on Article 107 of the Prison Act or Article 99 of the Detention Act. If multiple reasons for not accepting the appeal apply to the same case, please list each reason separately (J), and other cases (E).
7. Number of litigation cases (S): Refers to the appeal cases in which the agency engaged in litigation with the appellant regarding the appeal (including cases won (T), cases lost (U), cases with partial win and partial loss (V), cases dismissed (W), cases in progress (X), other cases (Y)). If the same case is at the court litigation stage and an appeal is filed, only count it as one case, do not duplicate.
